

ANNONA Terms of Service

IMPORTANT—PLEASE READ CAREFULLY: This is a legally binding contract. By clicking on the “Accept” button, you indicate your acceptance of these terms and conditions on behalf of your corporation, organization or other legal entity (“Licensee”), and you represent that you are authorized to bind Licensee to this Terms of Service Agreement (this “Agreement”). Read all of the terms and conditions of this Agreement. If you do not agree to be bound by this Agreement in its entirety, please do not click the “Accept” button associated with this agreement and do not attempt to use any of the products accompanying this Agreement.

This Agreement relates to an Annona, P.B.C. (“Licensor”) product (the “Product”) composed of software, software platform (including front-end web interface and back-end payment infrastructure), mobile application and mobile application (collectively, the “Software”) and related explanatory materials (“Documentation”) that are proprietary to Licensor and/or its licensor(s). The terms “Software” and “Documentation” also include any modified versions or updates of the Software and Documentation, respectively, to which Licensee may be granted access under this Agreement.

CHANGES TO TERMS. Licensor may change this Agreement from time to time without prior notice. You can review the current version of this agreement at any time at [Annona.co/AnnonaTermsOfService.pdf](https://annona.co/AnnonaTermsOfService.pdf). The revised terms and conditions will become effective upon posting and if Licensee uses the Product after that date, Licensor will treat the use as acceptance of the revised terms and conditions. If any change to this Agreement is not acceptable to the Licensee, the Licensee’s only remedy is to stop accessing and using the Software.

CHANGES TO PRODUCT. Licensor continuously updates and improves the Product. Licensor reserves the right, in its sole discretion, to add, alter, or remove functionality from the Product at any time without prior notice. Licensor may also limit, suspend, or discontinue a Product feature at its discretion.

LICENSE GRANT. Subject to the provisions of this Agreement, Licensor grants Licensee a non-exclusive, non-transferable, non-sublicensable, personal, limited license to do the following: access and use annona.co and any other web sites authorized by Licensor and install and run the Annona (Ona) mobile application and any other software authorized and provided by Annona on devices owned or controlled by Licensee.

RESTRICTIONS. Except as expressly set forth in this Agreement, Licensee may not do any of the following, nor permit any third party to do any of the following: (a) use, reproduce, modify or prepare derivative works of any portion of the Product or incorporate any portion of the Product into any other product; (b) transfer, encumber, sublicense, disclose, rent, lease, offer for timesharing or distribute any portion of the Product, except in connection with authorized distribution in accordance with this Agreement; or (c) remove, obscure, deface or fail to reproduce in any copy any copyright, trademark or other proprietary rights notice contained in any part of the Product. In addition, Licensee will not do any of the following, nor permit any third party to do any of the following, to any portion of the Product: reverse engineer, decompile, disassemble or otherwise attempt to determine the source code, ideas, algorithms or structure underlying any of the Product.

DATA RIGHTS. Licensee acknowledges and agrees that Licensor’s Software (i) collects raw data on payments and activity from the individuals, families, organizations, and businesses that sell to the Licensee (“End-Users”) that are uploaded to the Licensor’s

Software; (ii) collects raw data on usage and performance of registered accounts entered in by End-Users; (iii) collects personally identifiable information (“PII”) of End-Users that can be used to identify a specific individual (including, but not limited to, name, telephone number, GPS location); (iv) records and analyzes interactions with Licensor’s Software; and (v) analyzes raw data and PII; in each case for the purposes of providing, testing, evaluating, and improving the Product, and developing and deploying additional services and functionality that enhance the Licensee’s experience with the Product. The Licensee reserves the right to use, in any manner they see fit, all PII and raw data collected through their use of the Software. By using the Software, Licensee hereby grants Licensor a perpetual, worldwide, fully transferable, irrevocable, royalty-free license to collect, use, reproduce, store, modify, combine, transmit, create derivative works from, and distribute and display the data in any manner and for any purpose, as long as it is rendered in an anonymized and aggregated form that does not permit the identification of the Licensee or any End-User, unless explicitly requested by the Licensee or End-User, respectively, or for Licensee’s own use of the Software.

Licensor grants no additional rights to information delivered by the Software. This information may include statistics derived from - and insights or recommendations related to - Licensor’s analyses of raw data. Licensee may not transfer or otherwise distribute this information without Licensor’s express written permission.

Licensor may access Licensee’s account or instance at any time in order to assist Licensee with successful use of the Software.

SERVICE PROVIDERS. Information, including data collected by the Software and any PII contained therein, may be shared with certain third-party companies and individuals for technical and administrative aspects of the Software (e.g., credit card processing), or to perform functions related to the administration of the Software (e.g., hosting services). These third parties perform tasks on behalf of the Licensor and are contractually obligated not to disclose or use Software data for any other purpose and to employ adequate security measures to prevent unauthorized access to such data. However, Licensor is not responsible in the event that data are disclosed as a result of a breach or security lapse by any such third party.

CONNECTIVITY. Licensor is not responsible for ensuring availability of mobile or internet services required to access or make full use of the Product.

TERMINATION. Without prejudice to any other rights that may be available to it, Licensor may terminate this Agreement if Licensee breaches any provision of this Agreement. Licensor reserves the right to terminate this Agreement if the monthly sum of Licensee’s End-User payments processed by the Software falls below \$50 for three consecutive months at any time after use of the Product begins. Upon termination, all licenses hereunder will terminate and Licensee shall immediately cease all access to and use of the Product. The limitations of liability, data rights, restrictions, disclaimers, proprietary rights, general provisions, and confidentiality provisions of this Agreement will survive any termination hereof. After termination, Licensor will have no obligation to maintain or provide to Licensee any of Licensee’s Data.

SUSPENSION OF SERVICE. If any amount owed by Licensee under this or any other agreement for Licensor’s services is 10 or more days overdue, Licensor may, without limiting Licensor’s other rights and remedies, suspend Licensor’s services to Licensee until such amounts are paid in full.

PROPRIETARY RIGHTS. Except for the limited licenses expressly set forth in this Agreement, all right, title and interest in and to the Product and all portions thereof shall remain with Licensor and/or its licensor(s). Licensee acknowledges such ownership and intellectual property rights and will not take any action to jeopardize, limit or interfere in any manner with Licensor's or its licensors' ownership of or rights with respect to the Product.

ASSIGNMENT. Licensor may assign or transfer this Agreement, in whole or in part, without restriction.

FEEDBACK. Licensee may, on a voluntary basis, provide Licensor with feedback, ideas, comments, or suggestions about the Product or other Licensor products and services ("**Feedback**"). If Licensee provides Feedback, Licensee grants to Licensor a worldwide, royalty-free, non-exclusive, perpetual, and irrevocable license to use, copy, modify, and otherwise exploit the Feedback for any purpose and in any form or medium, without restriction or obligation to Licensee.

CONFIDENTIALITY. Licensee acknowledges and agrees that the Product constitutes proprietary and confidential information, as well as trade secrets, of Licensor and/or its licensors. Accordingly, Licensee will not disclose any portion of the Product to any third party, except for employees, agents or representatives of Licensee providing services to Licensee in connection with activities that are expressly permitted by this Agreement. Licensee will be liable for any use or disclosure made by any such employee, agent or representative of any part of the Product as if Licensee had made the same use or disclosure.

LICENSOR REPRESENTATIVES. A "Licensor Representative" is an employee, contractor, advisor or consultant of Licensor. Licensor may disclose confidential information and Product data to Licensor Representatives if those Representatives have a need to know for successful completion of their work- related activities. Before disclosure, Licensor will:

- ensure that Licensor Representatives are required to protect the confidential information on terms consistent with this agreement;
- and
- accept responsibility for each Representative's use of confidential information and/or Product data.

DISCLAIMER OF WARRANTY. Licensor is committed to ensuring service quality and uptime excellence to provide Licensee with an optimal experience when using the Product. While the Licensor always endeavors to keep the Software running, Licensee acknowledges that the Software may be unavailable for short periods from time to time for maintenance and system improvements. In order to maintain excellent customer service, the Licensor will work diligently with Licensee to address any issues that arise. With the understanding that it is in Licensor's best interest to provide superior service, LICENSEE SPECIFICALLY ACKNOWLEDGES AND AGREES THAT ITS USE OF THE PRODUCT WILL BE AT ITS OWN RISK AND THAT THE PRODUCT AND ALL PORTIONS THEREOF ARE PROVIDED ON AN "AS IS" BASIS, AND TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, LICENSOR, ITS AFFILIATES, ITS LICENSORS, THIRD-PARTY CONTENT OR SERVICE PROVIDERS, AND SUPPLIERS DISCLAIM ALL GUARANTEES AND WARRANTIES, WHETHER EXPRESS, IMPLIED, OR STATUTORY REGARDING THE PRODUCT, INCLUDING WITHOUT LIMITATION THE WARRANTIES THAT THEY ARE FREE OF DEFECTS, MERCHANTABILITY, FIT FOR A PARTICULAR PURPOSE, ACCURATE, NON-INTERFERING OR NON-INFRINGEMENT. LICENSOR DOES NOT WARRANT THAT THE SOFTWARE WILL PERFORM, EXCEPT TO THE EXTENT STATED IN THE DOCUMENTATION. LICENSOR DOES NOT WARRANT THAT THE SOFTWARE IS SECURE, FREE FROM BUGS, VIRUSES, INTERRUPTION, ERRORS, THEFT OR DESTRUCTION OR THAT THE SITE WILL MEET REQUIREMENTS. LICENSEE EXPRESSLY

UNDERSTANDS AND AGREES THAT LICENSEE BEARS ALL RISKS ASSOCIATED WITH USING OR RELYING ON THAT CONTENT. LICENSOR IS NOT LIABLE OR RESPONSIBLE IN ANY WAY FOR ANY CONTENT POSTED ON OR LINKED FROM THE PRODUCT, INCLUDING, BUT NOT LIMITED TO, ANY ERRORS OR OMISSIONS IN CONTENT, OR FOR ANY LOSSES OR DAMAGE OF ANY KIND INCURRED AS A RESULT OF THE USE OF OR RELIANCE ON ANY CONTENT. THIS DISCLAIMER OF WARRANTY CONSTITUTES AN ESSENTIAL PART OF THIS AGREEMENT, AND AS PARTIAL CONSIDERATION FOR BEING GRANTED THE LICENSES HEREUNDER LICENSEE AGREES TO BE BOUND BY THIS DISCLAIMER AND THE LIMITATIONS OF LIABILITY BELOW NOTWITHSTANDING THE FAILURE OF ANY REMEDY HEREUNDER OF ITS ESSENTIAL PURPOSE. LIMITATIONS OF LIABILITY. THE FOREGOING LIMITATIONS OF LIABILITY FORM AN ESSENTIAL PART OF THIS AGREEMENT AND LICENSOR WOULD NOT HAVE ENTERED INTO THIS AGREEMENT BUT FOR THE SAME. SOME JURISDICTIONS DO NOT ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES IN CERTAIN CIRCUMSTANCES, SO THIS EXCLUSION AND LIMITATION MAY NOT APPLY TO LICENSEE IN WHOLE OR IN PART.

COMPLIANCE WITH LAWS. Licensee agrees to comply with all applicable laws and regulations, domestic and foreign, with respect to the Product, including without limitation those related to export and import controls, confidentiality and protection of personal data. Licensee further agrees to comply with all local law and regulatory requirements necessary to ensure that Licensee's employees, agents and representatives comply with the terms of this Agreement as if they were parties hereto.

INDEMNIFICATION. Licensee shall indemnify, defend and hold Licensor harmless against any and all third party claims for losses, costs, liabilities, and damages finally awarded by a court of competent jurisdiction against Licensor in connection with such claims or agreed to in a settlement, including reasonable attorneys' fees, which (i) are caused by or resulting in whole or in part from Licensee's acts or omissions constituting bad faith, willful misfeasance, gross negligence or reckless disregard of Licensee's duties under this Agreement; (ii) are arising out of or related to Licensee's breach of obligations or restrictions set forth in this Agreement; (iii) are arising out of any violation by Licensee of any applicable law or the reasonable policies and procedures adopted in writing and provided to Licensee from time to time during the term of this Agreement that Licensee is obligated to comply with under this Agreement; provided that Licensor (a) notifies Licensee promptly in writing of any such action, (b) gives Licensee exclusive control and authority over the defense or settlement of such action, (c) does not enter into any settlement or compromise of any such action without Licensee's prior written consent and (d) provides all reasonable assistance to Licensee at Licensee's request.

Licensor shall indemnify, defend and hold Licensee harmless against any and all third party claims alleging that the Product infringes any valid U.S. patent or copyright for losses, costs, liabilities, and damages finally awarded by a court of competent jurisdiction against Licensee in connection with such claims or agreed to in a settlement, including reasonable attorneys' fees, provided that Licensee (a) notifies Licensor promptly in writing of any such action, (b) gives Licensor exclusive control and authority over the defense or settlement of such action, (c) does not enter into any settlement or compromise of any such action without the prior written consent of Licensor and (d) provides all reasonable assistance to Licensor at the request of Licensor. If the Product becomes, or in the opinion of Licensor may become, the subject of an infringement claim, Licensor may, at its option, (a) procure for Licensee the right to continue using the Product, (b) modify or replace the Product with substantially equivalent non-infringing products.

Notwithstanding anything contained in this Agreement; Licensor shall have no indemnification obligations with respect to any third party action alleging that (i) the use of the Product or any part thereof, in combination with products or technology not supplied by Licensor, or (ii) any service or service or other process utilizing the Product, infringes any third party intellectual property right, and in such event Licensee will indemnify, defend and hold harmless Licensor, and its officers, directors, and employees, against any such action, and Licensee will pay all settlements entered into, and all final judgments and costs (including reasonable attorneys' fees) awarded against such party in connection with such action; provided Licensor (a) notifies Licensee promptly in writing of any such action, (b) gives Licensee exclusive control and authority over the defense or settlement of such action, (c) does not enter into any settlement or compromise of any such action without Licensee's prior written consent and (d) provides all reasonable assistance to Licensee at Licensee's request and expense.

THIS SECTION STATES THE ENTIRE LIABILITY FOR LICENSOR AND THE SOLE REMEDY FOR LICENSEE FOR ANY CLAIM OF INFRINGEMENT OF ANY INTELLECTUAL PROPERTY RIGHTS BY THE PRODUCTS.

GENERAL. This Agreement shall be governed by applicable U.S. federal law and the laws of the State of Delaware, excluding any conflict of law provisions. This Agreement shall not be governed by the United Nations Convention on Contracts for the International Sale of Goods. The parties hereby consent to the exclusive jurisdiction of the U.S. federal and Delaware state courts located in Dover, Delaware, in connection with any dispute arising out of or in connection with this Agreement or its subject matter, and the parties irrevocably waive any right that they may have to assert that any such court lacks jurisdiction or that such forum is not convenient. If any provision in this Agreement should be held illegal or unenforceable by a court having jurisdiction, such provision shall be modified to the extent necessary to render it enforceable without losing its intent, or severed from this Agreement if no such modification is possible, and other provisions of this Agreement shall remain in full force and effect. The controlling language of this Agreement is English. If Licensee has received a translation into another language, it has been provided for Licensee's convenience

only. A waiver by either party of any term or condition of this Agreement or any breach thereof, in any one instance, shall not waive such term or condition or any subsequent breach thereof. Licensee may not assign or otherwise transfer, by operation of law or otherwise, this Agreement or any rights or obligations hereunder. Any such purported transfer or assignment will be void. Subject to the foregoing sentence, this Agreement shall be binding upon and shall inure to the benefit of the parties, their successors and assigns. The relationship between Licensor and Licensee is that of independent contractors and neither Licensee nor its employees, agents or representatives shall have any authority to bind Licensor in any way. This Agreement is intended by the parties to be the final expression of their agreement as to the matters covered by this Agreement, constitutes the complete and exclusive statement of the mutual understanding of the parties relating to the subject matter hereof, and supersedes all previous agreements and understandings, oral or written, relating to the subject matter hereof.
